# What is a DUI

### Kentucky law states that:

"Operating a motor vehicle with blood alcohol concentration (BAC) of or above 0.08, or of or above 0.02 for persons under age twenty-one, or while under the influence of alcohol or other substance which impairs driving ability ." (189A.010)

Zero Tolerance Offender is defined as a person under the age of 21 years old who is convicted of being in control of a motor vehicle while having a BAC between .02 and .08 grams of alcohol per 100 milliliters of blood, or per 210 liters of breath.

For a 1st offense DUI: Kentucky law requires an assessment and an education or treatment program.

If education is appropriate, Kentucky's standard is twenty (20) hours of alcohol and other drug education.

If further assessment or treatment is appropriate then the amount of treatment, determined at the time of the assessment, must be completed in order for Kentucky to clear the individual's driving record. Kentucky's maximum period of time for a 1st offender to be in treatment is ninety (90) days.



For 2nd and subsequent DUI offense within a five year period, Kentucky law requires an assessment and completion of a year-long treatment program.

# Penalties



### Penalties for Adult DUI, first offense within a 5 year period are:

- \$200 to \$500 fine.
- 2 to 30 days in jail.
- 30 to 120 day license suspension.
- An assessment must be performed to determine the appropriate level of care.
- Up to 90 days in an alcohol or substance abuse education and/ or treatment program.
- Service Fee (\$40 assessment fee + fees for education classes and/or treatment.

### Penalties for a Under 21 DUI conviction:

- Suspension of driving privilege or license for a period of no less than 30 days but no longer than 6 months.
- \$100 to \$500 fine.
- An assessment must be performed to determine the appropriate level of care.
- 1st offenders are sentenced to attend an alcohol or substance abuse education and/or treatment program.
- Treatment/Education shall be for a period of 90 days.

### Steps to Schedule a DUI Assessment at Four Rivers Behavioral Health

- 1. Contact the Regional Prevention and Education Center regarding questions. (270)442-8039
- 2. Contact Customer Service to schedule assessment. (866-316-8307)
- 3. Arrive to scheduled appointment 30 minutes early to complete paperwork. Please bring AOC, citation, and \$40 assessment fee.
- \* Under 21/Zero Tolerance please bring AOC, citation and \$40 assessment fee.
- 4. The assessment process includes the administration of assessment instrument and an interview with a certified assessor. The assessor will determine the appropriate level of care in relation to the individual's needs, and will discuss the available options with the individual. The assessor will then make all necessary referrals.

### DUI Programs offered through Four Rivers Behavioral Health

Upon completion of the assessment, the assessor will determine whether education, individual/group treatment, residential treatment, or a combination of the above is appropriate.

Additional information regarding the programs are as follows:

**KAODEP:** Twenty (20) hour adult education program created to help participants examine and change high-risk behavior.

- Consists of eight (8) sessions that can be completed in approximately 2 1/2 weeks.
- To accommodate the needs of consumers, classes are offered in Mayfield, Murray, and Paducah. The certified instructor will be present at one of above locations and will connect via video conference with the other two locations. Consumers at all locations will be able to interact and participate with each other, as if they were face-to-face in the same room.
- Orientation is held every Tuesday from 2-4pm.
- All other sessions are held on Tuesdays, Wednesdays, and Thursdays from 5-8pm, on an ongoing basis.
- Daytime classes are scheduled as needed.

PRI Prime for Life for Zero Tolerance— Is a five week curriculum program designed to reduce problems caused by high-risk drinking or drug use; to reduce the risk for long-term health problems and short-term impairment problems; to help people successfully protect the things they value.

• Classes are held Monday nights from 5-8pm at Four Rivers Behavioral Health in Paducah.

## Additional DUI Programs

**Outpatient Services—** are offered for male and female adults and adolescents.

- Services range from individual therapy to ongoing group sessions.
- Times vary based on location and services.

**Residential treatment—** is offered through the Fuller Center in Mayfield.

- Fuller is a licensed residential medically monitored treatment program for 24 male and female adults.
- Typically a 15-45 day program, which includes a nonmedical detoxification unit.
- Individual and group therapy.
- Introduction to daily living and recreation activities.



# Final Completion

- After education and/or treatment is complete and all fees are paid consumers shall be compliant and certificate of completion will be issued.
- The certified assessor takes completion forms to the Department of Transportation (DOT) every Friday morning.
- Once completion forms are turn in to the DOT consumers are instructed to go to their local County Clerk's office after 12 pm.
- Once at the County Clerk's office, consumers pay a \$40 reinstatement fee along with licensing fees ranging from \$12-\$20.

Instructions for Non-Kentucky Licensees
According to KY Division of Mental Health & Substance Abuse Services:
Instead of meeting Kentucky's DUI requirements, out of state licensees
may complete a program out of state that would be acceptable to the
home state as if the DUI was received there instead of in Kentucky.

# Failure to complete the education/treatment program and fee requirements

#### KRS 189A.040

Failure to complete the education or treatment program or to pay the amount specified by the court for education or treatment shall constitute contempt, and the court shall, in addition to any other remedy for contempt, reinstitute all penalties which were previously imposed but suspended or delayed pending completion of the education or treatment program.
