Policy: Compliance with Prison Rape Elimination Act (PREA)

CenterPoint Recovery Center for Men will make every effort to comply with the Prison Rape Elimination Act of 2003.

Procedure:

1. All new employees, volunteers, interns, and persons affiliated with CenterPoint and its clients on a regular or recurring basis will receive training regarding PREA standards, laws, and CenterPoint and AACS policies related to Code of Ethics and Dual Relationships. Refresher training will occur on a yearly basis. Failure to abide by PREA standards may result in personnel action up to and including termination and/or criminal prosecution.
2. Upon admission to the program, CenterPoint clients will receive education regarding but not limited to the following: expectations for appropriate behavior, how to report an incident, client rights, how to access support services, etc...
3. PREA related allegations will be reported to the Kentucky Department of Corrections as well as law enforcement personnel if the allegation involves force, coercion, or threats. Report to DOC should occur within 24 hours of an allegation.
4. CenterPoint will establish a relationship with the local Kentucky Association of Sexual Assault Programs service provider to ensure clients have access to support services.
5. The CenterPoint Director will serve as the PREA Coordinator and will be responsible for all required monthly and/or yearly reports. The Phase II Coordinator will serve as back up coordinator.
6. There will be independent PREA audit conducted once every three years as required by Kentucky Department of Corrections.
